# **2021 SENATE BILL 638**

AN ACT *to create* 20.285 (1) (em) and 36.27 (3q) of the statutes; **relating to:**resident undergraduate tuition remission at the University of Wisconsin
System for student teachers and making an appropriation.

## Analysis by the Legislative Reference Bureau

This bill provides for a semester of full undergraduate tuition remission to resident undergraduate students enrolled in a teaching program at a University of Wisconsin System institution during the student's semester of student teaching.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 4 **Section 1.** 20.285 (1) (em) of the statutes is created to read:
- 5 20.285 (1) (em) Student teacher tuition remission. A sum sufficient to reimburse the University of Wisconsin System for student teacher tuition remissions under s. 36.27 (3q).
  - **Section 2.** 36.27 (3g) of the statutes is created to read:

36.27 (3q) Tuition remission for student teachers. (a) In this subsection,
"student teacher" means an individual enrolled as a resident undergraduate student
in the system who is participating in the student teaching component of a teacher
preparatory program in this state approved by the state superintendent of public
instruction under s. 115.28 (7) (a).

- (b) The board shall grant full remission of resident undergraduate tuition to student teachers during their semester of student teaching.
- (c) The cost to the system of remissions under this subsection shall be paid from the appropriation account under s. 20.285 (1) (em).

### **SECTION 3. Initial applicability.**

(1) This act first applies to individuals who commence student teaching in the first semester that begins after the effective date of this subsection.

### SECTION 4. Effective date.

(1) This act takes effect on the first day of the 3rd month beginning after publication.
