2021 SENATE BILL 647

October 20, 2021 - Introduced by Senators PFAFF, SMITH, ERPENBACH, LARSON and RINGHAND, cosponsored by Representatives CONSIDINE, S. RODRIGUEZ, CABRERA, CONLEY, EMERSON, HEBL, B. MEYERS, NEUBAUER, OHNSTAD, POPE, SHANKLAND, SHELTON, SPREITZER, STUBBS, SUBECK and VRUWINK. Referred to Committee on Agriculture and Tourism.

1 **AN ACT to create** 20.115 (3) (f) of the statutes; **relating to:** the Something Special
2 from Wisconsin promotional campaign; funding for the University of Wisconsin
3 System, technical colleges, and special education aid; and making an
4 appropriation.

Analysis by the Legislative Reference Bureau

Under current law, the Department of Agriculture, Trade and Consumer Protection administers the "Something Special from Wisconsin" promotional campaign to promote commodities produced in this state. The bill creates a new continuing appropriation and provides \$400,000 in fiscal year 2021-22 from the general fund for this purpose.

The bill also provides additional funding, in fiscal year 2021-22, for the University of Wisconsin System under its general program operations appropriation; for state aid for technical colleges; and for special education aid the Department of Public Instruction pays to school districts, independent charter schools, cooperative educational service agencies, and county children with disabilities education boards.

13 **SECTION 3. Fiscal changes.**

14 (1) SPECIAL EDUCATION AID. In the schedule under s. 20.005 (3) for the
15 appropriation to the department of public instruction under s. 20.255 (2) (b), the
16 dollar amount for fiscal year 2021-22 is increased by \$252,000 to increase funding
17 for aids for special education under s. 115.88.

18 (2) UW SYSTEM; GENERAL PROGRAM OPERATIONS. In the schedule under s. 20.005
19 (3) for the appropriation to the Board of Regents of the University of Wisconsin
20 System under s. 20.285 (1) (a), the dollar amount for fiscal year 2021-22 is increased
21 by \$51,660 for the purpose for which the appropriation is made.

22 (3) STATE AIDS FOR TECHNICAL COLLEGES. In the schedule under s. 20.005 (3) for
23 the appropriation to the technical college system board under s. 20.292 (1) (d), the
