2015 SENATE BILL 757

February 17, 2016 – Introduced by Senator GUDEx, cosponsored by Representative SCHRAA. Referred to Committee on Education.

AUTHORS SUBJECT TO CHANGE

1 **AN ACT** *to amend* 118.60 (2) (a) 6. a. and 119.23 (2) (a) 6. a.; and *to create* 118.60
2 (2) (a) 6. e. and 119.23 (2) (a) 6. d. of the statutes; **relating to:** licensure for
3 substitute teachers at private schools participating in a parental choice
4 program.

Analysis by the Legislative Reference Bureau

This bill exempts certain substitute teachers from the requirement to have a bachelor's degree or higher educational credential, or a teaching license issued by the Department of Public Instruction, as a prerequisite to teaching at a private school participating in a parental choice program.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

15 degree or a degree or educational credential higher than a bachelor's degree,
16 including a masters or doctorate, from a nationally or regionally accredited
17 institution of higher education.

18 **SECTION 4.** 119.23 (2) (a) 6. d. of the statutes is created to read:

19 119.23 (2) (a) 6. d. The requirement under subd. 6. a. does not apply to an
20 individual employed as a substitute teacher at a private school in the 2015-16 school
21 year or in any school year thereafter if the individual has been employed as a
22 substitute teacher at the same private school for at least 5 consecutive school years
23 preceding the 2015-16 school year and the private school first participated in the
24 program under this section after July 1, 2015.
