## 2021 SENATE BILL 870

January 13, 2022 - Introduced by Senator ROTH, cosponsored by Representatives MURPHY, AUGUST, ARMSTRONG, BEHNKE, GUNDRUM, KNODL and PENTERMAN. Referred to Committee on Housing, Commerce and Trade.

1 **AN ACT to create** 134.55 of the statutes; **relating to:** prohibiting the sale of goods  
2 from the Xinjiang region of China.

### *Analysis by the Legislative Reference Bureau*

This bill prohibits the sale at retail or at wholesale of goods mined, produced, or manufactured in the Xinjiang region of China unless 1) the U.S. Customs and Border Protection bureau determines that the good was not mined, produced, or manufactured with forced labor; 2) the Wisconsin Economic Development Corporation determines that the good was not mined, produced, or manufactured with forced labor; or 3) a federal law allows the sale of the good.

Under the bill, WEDC must establish policies and procedures providing due diligence and supply chain tracing and management standards ensuring that goods transported into this state were not mined, produced, or manufactured wholly or in part by forced labor in the Xinjiang region of China. The bill also authorizes WEDC to request information from a person who transports goods into this state to determine whether the goods were mined, produced, or manufactured wholly or in part by forced labor in the Xinjiang region of China.

If a state or federal court enjoins any of the provisions described above, the bill provides that no person may sell goods mined, produced, or manufactured in the Xinjiang region of China without having a label affixed to the good's packaging stating, "Made with slave labor."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

1           **SECTION 1.** 134.55 of the statutes is created to read:

2           **134.55 Sale of goods from Xinjiang region. (1)** No person may sell or offer  
3 for sale at retail or at wholesale a good mined, produced, or manufactured wholly or  
4 in part in the Xinjiang region of China unless any of the following applies:

5           (a) The U.S. customs and border protection bureau determines that the good  
6 was not mined, produced, or manufactured wholly or in part by forced labor.

7           (b) The Wisconsin Economic Development Corporation determines that the  
8 good was not mined, produced, or manufactured wholly or in part by forced labor  
9 according to the policies and procedures established under sub. (2) (a).

10          (c) A federal law enacted or promulgated after the effective date of this  
11 paragraph .... [LRB inserts date] allows the sale of the good.

12          **(2) (a)** The Wisconsin Economic Development Corporation shall establish  
13 policies and procedures providing all of the following:

14           1. Due diligence and supply chain tracing and management standards that  
15 ensure that a person transporting goods into this state does not transport goods that  
16 were mined, produced, or manufactured wholly or in part by forced labor in the  
17 Xinjiang region of China.

18           2. The type, nature, and extent of evidence that demonstrates that a good was  
19 not mined, produced, or manufactured wholly or in part in the Xinjiang region of  
20 China.

1           3. The type, nature, and extent of evidence that demonstrates that a good was  
2 not mined, produced, or manufactured wholly or in part by forced labor.

3           (b) The policies and procedures established under par. (a) shall be consistent  
4 with any federal law enacted or promulgated after the effective date of this  
5 paragraph .... [LRB inserts date] that establishes standards for determining whether  
6 goods were mined, produced, or manufactured wholly or in part by forced labor in the  
7 Xinjiang region of China.

8           (c) The Wisconsin Economic Development Corporation may request  
9 information from a person who transports goods into this state to determine whether  
10 the goods were mined, produced, or manufactured wholly or in part by forced labor  
11 in the Xinjiang region of China.

12           **(3)** If a state or federal court of competent jurisdiction enjoins the enforcement  
13 of sub. (1) or (2), no person may sell or offer for sale at retail or at wholesale a good  
14 mined, produced, or manufactured wholly or in part in the Xinjiang region of China  
15 without having a label affixed to the packaging of the good, including the retail  
16 packaging, stating, "Made with slave labor."
