5 "15. (a) No funds appropriated under this section shall be expended  
6 for any gender transition or gender reassignment procedures or any  
7 procedure for the purpose of procuring or performing an abortion  
8 on any person.

10 (b) For purposes of subsection (a) of this footnote, "gender  
11 transition or gender reassignment procedures":

12

13 (i) Shall include, but not be limited to, any of the  
14 following:

15

16 (A) A surgery that aids in gender transitioning or  
17 gender reassignment;

18

19 (B) A procedure that provides, administers,  
20 prescribes or dispenses any of the following prescription drugs  
21 that induce transient or permanent infertility:

22

23 (I) Puberty suppression or blocking  
24 prescription drugs to stop or delay normal puberty;

25

26 (II) Supraphysiologic doses of testosterone  
27 to females;

28

29 (III) Supraphysiologic doses of estrogen to  
30 males.

31

32 (ii) Shall not include any procedures or treatments  
33 that are performed for a person who is born with a medically  
34 verifiable genetic disorder of sex development, including 46, XX  
35 chromosomes with virilization, 46, XY chromosomes with  
36 undervirilization or both ovarian and testicular tissue.

1 (c) For purposes of subsection (a) of this footnote,  
2 "abortion":

3  
4 (i) Shall include any instrument, medicine, drug or any  
5 other substance, device or means administered with the intent to  
6 terminate the clinically diagnosable pregnancy of a woman,  
7 including the elimination of one (1) or more unborn babies in a  
8 multifetal pregnancy, with knowledge that the termination by those  
9 means will, with reasonable likelihood, cause the death of the  
10 unborn baby;

11 (ii) Shall not include any of the following:

12 (A) A procedure to save the life or preserve the  
13 health of the unborn baby;

14 (B) A procedure to remove a dead unborn baby caused  
15 by spontaneous abortion or intrauterine fetal demise;

16 (C) Treatment of a woman for an ectopic pregnancy;  
17 or

18 (D) Treatment of a woman for cancer or another  
19 disease that requires medical treatment, which treatment may be  
20 fatal or harmful to the unborn baby.".
