27 2. This appropriation is for purposes of the Riverton state office building  
28 renovation project. This appropriation is contingent upon the acquisition of an  
29 office building by the state for the Riverton state office building project.  
30 Funds from this appropriation shall be prioritized for the renovation of the  
31 second floor of the office building prior to any other expenditures.
