Cease and transfer priority list.

Sponsored by: Joint Minerals, Business & Economic
Development Interim Committee

A BILL

for

1 AN ACT relating to prioritization of municipal solid waste
2 facilities cease and transfer projects; authorizing
3 expenditure of previously appropriated funds; establishing
4 a prioritized list of projects; establishing a maximum
5 amount to be expended on the projects; granting the
6 department of environmental quality limited discretionary
7 authority to modify the prioritized list; providing
8 definitions; repealing a prior list of priority cease and
9 transfer projects; and providing for an effective date.

11 *Be It Enacted by the Legislature of the State of Wyoming:*

13 **Section 1.**

14

15 (a) As used in this section:

1

2 (i) "Maximum amount" means the total amount to
3 be expended on the listed project and reflects one hundred
4 percent (100%) of the project cost, including any award by
5 the state loan and investment board under W.S. 35-11-528;

7 (ii) "(C)" means closure project;

8

9 (iii) "SWDD" means solid waste disposal
10 district;

11

12 (iv) "(T)" means transfer projects.

14 (b) From amounts appropriated by 2013 Wyoming Session
15 Laws, Chapter 194, Section 2(a) and (b), 2014 Wyoming
16 Session Laws, Chapter 26, Section 333(a) and (b), 2015
17 Wyoming Session Laws, Chapter 142, Section 345 (priority
18 2), 2016 Session Laws, Chapter 31, Section 316(a) and other
19 funds appropriated and authorized for program expenses, the
20 following amounts and prioritized projects are authorized
21 pursuant to the municipal solid waste facilities cease and
22 transfer program created by W.S. 35-11-528:

5 (c) The department of environmental quality may
6 modify the authorized funds and the order of the projects
7 listed in the prioritized list contained in subsection (b)
8 of this section for any of the following reasons:

9

10 (i) To optimize efficiency;

11

12 (ii) Based on project readiness;

13

14 (iii) Based on compliance with grant or loan
15 qualifications or conditions;

16

17 (iv) To address emergency or immediate
18 environmental concerns.

19

20 (d) Not later than October 15 of each year, the
21 department of environmental quality shall report any
22 modification of the prioritized list contained in
23 subsection (b) of this section to the joint minerals,

1 business and economic development interim committee and the
2 joint appropriations committee.

4 **Section 2.** 2016 Wyoming Session Laws, Chapter 68 is
5 repealed.

6

7 **Section 3.** This act is effective immediately upon
8 completion of all acts necessary for a bill to become law
9 as provided by Article 4, Section 8 of the Wyoming
10 Constitution.
