Quarantine of animals.

A BILL

for

- 1 AN ACT relating to the quarantine of animals; providing for
- 2 testing, vaccination and quarantine of diseased animals;
- 3 providing for testing, vaccination, quarantine and sale of
- 4 animals imported into Wyoming; repealing requirements for
- 5 the dipping and spraying of animals; providing for a
- 6 penalty; providing conforming amendments; and providing for
- 7 an effective date.

9 Be It Enacted by the Legislature of the State of Wyoming:

10

- 11 **Section 1.** W.S. 11-1-103, 11-19-101 by creating a new
- 12 subsection (b) and by renumbering (b) as (c), 11-19-103(b),
- 13 (e) and by creating a new subsection (j) and 11-19-111 by
- 14 creating new subsections (d) and (e) are amended to read:

16 11-1-103. Penalty for violations.

- 2 A person who violates any of the following sections commits
- 3 a misdemeanor punishable by imprisonment for not more than
- 4 six (6) months, a fine of not more than seven hundred fifty
- 5 dollars (\$750.00), or both for the first offense, or by
- 6 imprisonment for not more than one (1) year, a fine of not
- 7 more than one thousand five hundred dollars (\$1,500.00), or
- 8 both for second or subsequent offenses: W.S. 11-6-210(a) or
- 9 (f), 11-18-112, 11-19-101, 11-19-102, 11-19-103, 11-19-111,
- 10 11-19-401, 11-20-114, 11-20-117, 11-20-229, 11-20-230,
- 11 11-21-104, 11-22-118, 11-23-106, 11-23-207, 11-24-106 and
- 12 11-30-114. A person who violates board rules promulgated
- 13 pursuant to W.S. 11-18-103(a)(v) shall be subject to the
- 14 penalties specified in this section.

- 16 11-19-101. Duties of state veterinarian generally;
- 17 failure to comply with provisions; penalty.

- 19 (b) The state veterinarian may inspect, treat, test,
- 20 vaccinate, quarantine or sell any animal imported into
- 21 Wyoming in violation of W.S. 11-19-111 or any rules

22 promulgated thereunder.

1 (b)(c) Any person failing to comply with this section

2 shall be punished as provided in W.S. 11-1-103.

4 11-19-103. Quarantine of diseased animals generally;

5 treatment, testing and vaccination thereof; effect of

6 failure to obey order of state veterinarian; appeal; stay

7 of action.

8

9 (b) Whenever the state veterinarian finds any

10 infectious or contagious disease among domestic animals in

11 any section of the state he shall take such steps as will

12 prevent the spread of the disease. As a sanitary measure,

13 he The state veterinarian may inspect and compel the

14 dipping, spraying or other treatment, testing, vaccination

or quarantine of all such animals in Wyoming found to be

16 infected or exposed to the disease, under such rules and

17 regulations as he may adopt. Any order or regulation made

18 by the state veterinarian is subject to review,

19 modification or annulment by the board at any subsequent

20 meeting.

21

(e) If the owner or persons in charge of animals

23 ordered treated, tested, vaccinated or quarantined after

24 reasonable notice determined by the veterinarian, fail to

1	dip, spray or otherwise treat, test, vaccinate or
2	quarantine such animals as ordered, the veterinarian may
3	seize or cause such animals to be seized and dipped,
4	sprayed or otherwise treated, tested, vaccinated or
5	quarantined and may hold and sell the animals, or part
6	thereof as necessary to pay all costs of inspection,
7	seizing, caring for, dipping, spraying or other treatment
8	treating, testing, vaccinating or quarantine together with
9	cost of sale. The sale shall be made at the time and place
10	and in the manner prescribed by the veterinarian. Not less
11	than three (3) days nor more than fifteen (15) days notice
12	of the time, place and purpose of the sale shall be given
13	by the veterinarian to the owner or persons in charge of
14	the animals, by personal service within the county in which
15	the animals are being held if possible, and if not possible
16	then such notice may be given either by personal service
17	outside of the county or by advertisement in any paper
18	selected by the veterinarian. The state veterinarian shall
19	only sell the livestock after all other remedies have been
20	exhausted.

21

22 (j) Any person failing to comply with this section shall be punished as provided in W.S. 11-1-103. 23

4	(d) The state veterinarian may inspect, treat, test,
5	vaccinate, quarantine or sell any livestock imported into
6	Wyoming in violation of W.S. 11-19-111 or any rules
7	promulgated thereunder. Any order or regulation made by
8	the state veterinarian is subject to review, modification
9	or annulment by the governor or the board at any subsequent
10	meeting.
11	
12	(e) An order of the state veterinarian under
13	subsection (d) of this section shall be subject to appeal
14	and due process as provided in W.S. 11-19-103.
15	
16	Section 2. W.S. 11-19-103(c) and (d) is repealed.
17	
18	Section 3. This act is effective immediately upon
19	completion of all acts necessary for a bill to become law
20	as provided by Article 4, Section 8 of the Wyoming
21	Constitution.
