- 9 **Section 1.** W.S. 31-5-203 by creating a new subsection
- 10 (b) and 31-5-301(b) (intro) and (c) are amended to read:

12 31-5-203. Rules governing overtaking on the left.

- 14 (b) A driver of a passenger car, motorcycle or pickup
- 15 truck, not towing any other vehicle, may exceed the speed
- 16 limit by up to ten (10) miles an hour while passing another

1 vehicle traveling at less than the legal maximum speed, in order to safely pass the vehicle. The overtaking vehicle 2 3 shall return to the right-hand lane and reduce speed to the 4 posted speed limit as soon as practicable. This subsection shall be applicable only upon roadways divided into two (2) 5 lanes for two (2) way movement of traffic and where the 6 posted speed limit is fifty (50) miles per hour or greater. 7 This subsection shall not be applicable in construction 8 9 zones. Passing a vehicle pursuant to this subsection shall be subject to all other applicable motor vehicle laws. A 10 11 driver of a vehicle exceeding the ten (10) mile per hour limitation of this subsection shall be subject to the full 12 13 penalty or penalties applicable to exceeding the posted 14 speed limit by the actual speed of the vehicle. As used in this section, "motorcycle," "passenger car," "pickup" and 15 "vehicle" mean as defined in W.S. 31-1-101. 16
