8 Be It Enacted by the Legislature of the State of Wyoming:

- 10 **Section 1.** W.S. 9-1-608(b) and 21-2-202(a)(xix)(H) are
- 11 amended to read:

9-1-608. Assistant attorneys general.

- 15 (b) With the approval of the governor the attorney
- 16 general may appoint special assistant attorneys general for

1 any purposes. A person shall not be employed as an attorney

2 or legal counsel by any department, board, agency,

3 commission or institution of the state, or represent the

4 state in that capacity, except by the written appointment of

5 the attorney general. Written appointment of the attorney

6 general shall not be required for the employment of legal

7 counsel by elected state officials.

9 21-2-202. Duties of the state superintendent.

11 (a) In addition to any other duties assigned by law,

12 the state superintendent shall:

13

14 (xix) Serve as the state agency to accept all

15 federal funds for aid to education, except as provided in

16 W.S. 21-2-307 and 21-2-601, and as the agency to administer

17 or supervise the administration of any state plan

18 established or federal funds subject to federal

19 requirements. Each acceptance is restricted in its effect

20 to the specific situation involved. The state

21 superintendent may:

23 (H) Take any other action as may be

24 necessary to secure the benefits of the federal statute to

- 1 the schools of this state. Nothing in this paragraph shall
- 2 be construed as conferring any authority to the state
- 3 superintendent with respect to the University of Wyoming or

- 6 **Section 2.** W.S. 9-1-307, 9-1-403(c)(viii), 9-1-409(d)
- 7 and 21-2-202(a)(xix)(J) are repealed.

- 9 **Section 3.** No funds appropriated for the 2013-2014
- 10 fiscal biennium, for the employment of legal counsel by an
- 11 elected official whose authority to employ counsel is
- 12 repealed by this act shall be expended and all such funds
- 13 shall revert on July 1, 2012 to the account from which they
- 14 were appropriated. To the extent 2012 House Bill 1
- 15 authorizes a legal counsel position within the budget of
- 16 the office or department under the control of any state
- 17 elected official whose authority to employ counsel is
- 18 repealed by this act, that authorization is hereby
- 19 nullified and the position terminated as of July 1, 2012.
- 20 The 2015-2016 standard biennial budget requests for all
- 21 such offices and departments shall be reduced to reflect

22 the provisions of this act.
