## A BILL

for

1 AN ACT relating to environmental quality; amending staffing

2 requirements, duties and procedures for the environmental

3 quality council; amending the duties of the director of the

4 department of administration and information and the director

5 of the department of environmental quality related to the

6 environmental quality council; amending duties of the

7 department of environmental quality's advisory boards; and

8 providing for an effective date.

10 Be It Enacted by the Legislature of the State of Wyoming:

12 **Section 1**. W.S. 9-2-1003 by creating a new subsection

13 (f), 35-11-111(d), 35-11-112(a)(ii), (d) and (e) and

1 9-2-1003. Director and division administrators; 2 appointment; removal; powers of director. 3 4 (f) The director shall administer through his office or through a division of the department the duties required under 5 6 W.S. 35-11-112(d). 7 8 35-11-111. Independent environmental quality council created; removal; terms; officers; meetings; expenses. 9 10 11 (d) The council shall hold at least four (4) regularly 12 scheduled meetings each year. Special meetings may be called 13 by the chairman, and special meetings shall be called by the chairman, upon a written request submitted by the director or 14 three (3) or more members. Four (4) members shall constitute 15 a quorum. All matters shall be decided by a majority vote of 16 17 those on the council. 18 19 35-11-112. Powers and duties of the environmental 20 quality council. 21 The council shall act as the hearing examiner for 22 the department and shall hear and determine all cases or 23

1 issues arising under the laws, rules, regulations, standards 2 or orders issued or administered by the department or its air 3 quality, land quality, solid and hazardous waste management 4 or water quality divisions. At the council's request the office of administrative hearings may provide a hearing 5 officer for any rulemaking or contested case hearing before 6 the hearing officer 7 the council, and may provide recommendations on procedural matters when requested by the 8 9 council. Notwithstanding any other provision of this act, 10 including this section, the council shall have no authority to promulgate rules or to hear or determine any case or issue 11 12 arising under the laws, rules, regulations, standards or 13 orders issued or administered by the industrial siting or 14 abandoned mine land divisions of the department. The council 15 shall:

(ii) Conduct hearings as required by the Wyoming Administrative Procedure Act for the adoption, amendment or repeal of rules, regulations, or standards or orders when recommended by the <u>director after the director consults with the advisory boards through and the administrators</u> and the <u>director</u>. The council shall approve all rules, regulations,

and standards or orders of the department before they become

2 final; 3 4 (d) The director and his staff shall provide the 5 council with council may employ an executive officer and staff who shall serve at the pleasure of the council. The executive 6 officer and other staff members shall perform duties as the 7 8 council may assign, including preparing meeting facilities, and completing administrative, secretarial or clerical 9 10 assistance, supplies and such other assistance as the council may require in the performance of its duties and other 11 12 functions. The chair of the council and the director of the 13 department of administration and information or his designee shall coordinate on hiring and evaluating the executive 14 officer and other staff members. The department of 15 16 administration and information shall provide suitable office space for the executive officer and other staff members and 17 shall ensure that any employment authorized under this 18 19 subsection complies with title 9, chapter 2, article 10 of 20 the Wyoming statutes. The council may negotiate and enter into appropriate memoranda of understanding with the 21 department of administration and information to facilitate 22 the staffing needs required under this subsection. 23
