Motor club services updates.

A BILL

for

1 AN ACT relating to insurance; amending definitions for
2 motor club services; amending requirements for motor club
3 membership cards or certificates; repealing requirements
4 and procedures for motor club agent licenses; and providing
5 for an effective date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

9 **Section 1.** W.S. 31-14-102(a)(vi), (vii), (xii) and
10 (xiv), 31-14-110, 31-14-115 and 31-14-116(a)(ii) and (v)
11 are amended to read:

13 **31-14-102. Definitions.**

14

15 (a) As used in this act:

1

2 (vi) "Discount service" means an arrangement by
3 a motor club resulting in giving special discounts, rebates
4 or reductions of price on gasoline, oil, repairs, parts,
5 accessories or service for motor vehicles or other goods
6 and services to holders of service contracts with the club;

7

8 (vii) "Emergency road service" means ~~the~~
9 ~~adjustment, repair or replacement~~ any act by a motor club
10 consisting of fuel delivery, extrication, lockout service,
11 key replacement, repair, replacement or other adjustment of
12 the equipment, tires or mechanical parts of a motor vehicle
13 so as to permit it to be operated under its own power;

14

15 (xii) "Motor club" means a person directly or
16 indirectly engaged, ~~either as principal or agent,~~ in
17 selling or offering for sale, furnishing or procuring motor
18 club service;

19

20 (xiv) "Service contract" means a written
21 agreement whereby any person promises for a consideration
22 to render, furnish or procure motor club service for any

1 other person and includes contracts satisfying the
2 requirements of W.S. 31-14-119;

3

4 **31-14-110. Continuation of certificate of authority.**

5

6 Every certificate of authority issued to a motor club shall
7 ~~expire annually on July 1, of each year, unless sooner~~
8 ~~revoked or suspended~~ continue in force until suspended or
9 revoked by the commissioner or terminated at the motor
10 club's request, subject to payment each year before July 1,
11 of the annual licensing fee provided in W.S.
12 31-14-109(a)(ii) and subject to providing proof of the
13 financial security requirement in W.S. 31-14-103 on a form
14 the commissioner prescribes.

15

16 **31-14-115. Proof of membership; date and signature on**
17 **service contract.**

18

19 Every service contract executed, issued or delivered in
20 this state shall be accompanied by a ~~membership card or~~
21 ~~certificate and shall be dated and signed by the motor club~~
22 ~~issuing it~~ proof of membership provided to the contract
23 holder.

2 **31-14-116. Contents of service contract.**

3

4 (a) A service contract shall not be executed, issued
5 or delivered in this state unless it contains the
6 following:

7

8 (ii) The exact location of its home office and
9 ~~of its usual place of business in this state, giving street~~
10 ~~number and city~~ any business office in the United States,
11 phone number, email address or other contact information to
12 which consumer inquiries may be made;

13

14 (v) A statement in not less than fourteen (14)
15 point ~~modern~~ bold type at the head of the contract stating,
16 "This is not an automobile liability or physical damage
17 insurance contract."

18

19 **Section 2.** W.S. 31-14-102(a)(iv) and 31-14-120
20 through 31-14-129 are repealed.

1 **Section 3.** This act is effective July 1, 2018.
