2 In exercising, performing or carrying out any power, 3 privilege, authority, duty or function legally vested in 4 any one (1) or more of them by Wyoming law, the state of Wyoming, and any one (1) or more of its counties, municipal 5 corporations, school districts, special districts, public 6 institutions, agencies, boards, commissions and political 7 8 subdivisions, and any officer or legal representative of any one (1) or more of them, may cooperate with and assist 9 each other, and like entities or authorities of other 10 11 states, the United States and the Eastern Shoshone and 12 Northern Arapaho Tribes of the Wind River Reservation. 13 Cooperation may be informal or subject to resolution, 14 ordinance or other appropriate action, and may be embodied in a written agreement specifying purposes, duration, means 15 16 financing, methods of operations, termination, acquisition and disposition of property, employment of 17 executive 18 and subordinate agents, reciprocation of 19 governmental immunity protections or other limitations of 20 liability pursuant to W.S. 16-1-104(f) and other 21 appropriate provisions.

Joint powers, functions and facilities; 2 city-county airport board; eligible senior citizen centers; 3 cooperative public transportation programs. 4 (f) An agency may enter into an agreement with any 5 6 governmental entity of another state, as defined in W.S. 1-39-103(a)(viii), for purposes of operating a cooperative 7 8 public transportation program to transport passengers on 9 one (1) or more routes beginning in, ending in or passing 10 through Wyoming. Any agreement entered into under this 11 subsection shall be conditioned upon the other state 12 extending or agreeing to extend its governmental immunity 13 or other limitations of liability to Wyoming for purposes 14 of operating a cooperative public transportation program. 15 As used in this subsection, "cooperative public 16 transportation program" means a not-for-profit program designed to transport passengers to and from work or to 17 18 another location on a regularly scheduled basis using 19 vehicles operated by an agency or a governmental entity of
