substance was obtained directly from, or pursuant to a 1 2 valid prescription or order of a practitioner while acting 3 in the course of his professional practice, or except as 4 otherwise authorized by this act. With the exception of 5 dronabinol listed in W.S. 35-7-1018(h), as notwithstanding any other provision of this act, no 6 practitioner shall dispense or prescribe marihuana, 7 8 tetrahydrocannabinol, or synthetic equivalents of marihuana 9 tetrahydrocannabinol and no prescription practitioner's order for marihuana, tetrahydrocannabinol, 10 11 synthetic equivalents of marihuana or 12 tetrahydrocannabinol shall be valid. Any person who 13 violates this subsection:

15 And has in his possession a controlled (i) 16 substance in the amount set forth in this paragraph is quilty of a misdemeanor punishable by imprisonment for not 17 more than twelve (12) months, a fine of not more than one 18 19 thousand dollars (\$1,000.00), or both. Any person 20 convicted for a third fourth or subsequent offense under 21 within ten (10) years of a conviction for a violation of this paragraph, including convictions for violations of 22 23 similar laws in other jurisdictions, shall be imprisoned
