W.S. 31-2-230 is created to read: 8 9 10 31-2-230. Wyoming native license plates. 11 12 (a) Any person required to register a vehicle in 13 Wyoming pursuant to W.S. 31-2-201 may apply to the department for a statement of eligibility for distinctive 14 Wyoming native license plates for any motor vehicle owned 15

by the applicant upon registration of the vehicle. Upon 1 2 payment by the applicant of a fee of one hundred dollars 3 (\$100.00) to the department, along with documentation 4 required under subsection (b) of this section, the 5 department shall issue a written statement of eligibility for Wyoming native license plates. Application shall be 6 made at least thirty (30) days before registration of the 7 8 vehicle expires. Any fees collected under this section 9 shall be payable to the department and shall be deposited 10 in the highway fund created by W.S. 9-4-204(u)(i).

12 Any person who was born in Wyoming and who (b) graduated from a Wyoming high school may apply for and use 13 14 a Wyoming native license plate. Any person who applies for 15 a Wyoming native license plate shall provide the department 16 with a copy of the applicant's Wyoming birth certificate 17 and proof of the applicant's graduation from a Wyoming high school at the time of application. The county treasurer 18 19 shall provide any applicant with an application form 20 developed by the department.

(c) License plates issued under this section shall bedisplayed upon the vehicle for which they are issued.

2	(d) Except as provided in this section, application
3	for, issuance and renewal of license plates shall be
4	subject to the same requirements and fees as provided in
5	this article. The fee required under W.S.
6	31-3-102(a)(viii) shall accompany each application.
7	
8	(e) The department shall prescribe the design of the
9	special license plate authorized by this section, which
10	shall include an image of the bucking horse and rider as
11	described in W.S. 8-3-117, in consultation with the
12	secretary of state's office, and arrange for production of
13	the license plates. Following initial approval, Wyoming
14	native license plates shall be subject to redesign on the
15	same schedule as all license plates beginning with the year
16	2017 reissuance. The license plates shall be issued by the
17	county treasurer of each county.

19	(f) The department may prepare any special forms and
20	issue any rules and regulations necessary to carry out this
21	section.
