Cancer awareness license plates.

A BILL

for

1 AN ACT relating to motor vehicles; authorizing a special
2 license plate for support of cancer prevention and
3 awareness; and providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 31-2-230 is created to read:

8

9 **31-2-230. Special plates; prevention and awareness.**

10

11 (a) Any person required to register a vehicle in
12 Wyoming may obtain distinctive cancer prevention and
13 awareness license plates for any motor vehicle owned or
14 leased by that person upon registration of the vehicle.
15 License plates issued under this section shall be displayed
16 only on the vehicle for which they are issued. The license

1 plates shall bear a distinctive symbol and letters
2 identifying the registrant as an individual supporting
3 cancer prevention and awareness.

4

5 (b) To obtain license plates under this section the
6 registrant shall submit a donation of at least one hundred
7 dollars (\$100.00) to the cancer control program established
8 and administered by the department of health. Proof of
9 payment issued by the department shall establish the
10 registrant's eligibility to receive a special cancer
11 prevention and awareness license plate from the county
12 treasurer. Donations to the cancer control program
13 collected under this section shall be payable to the
14 department of health and shall be deposited in an account
15 to be used in a manner consistent with the purposes of W.S.
16 35-25-203. The minimum donative amount authorized under
17 this section may be increased by the department of health
18 annually up to the percentage increase as shown by the
19 Wyoming cost-of-living index as determined by the division
20 of economic analysis of the department of administration
21 and information.

23 (c) Except as provided in this section, payment for
24 issuance and renewal of cancer prevention and awareness

1 license plates shall be subject to the same requirements
2 and fees as provided in this article. The fee required
3 under W.S. 31-3-102(a)(viii) shall apply to special license
4 plates described in this section.

5

6 (d) The department shall consult with the Wyoming
7 department of transportation to design a special cancer
8 prevention and awareness license plate as authorized by
9 this section and arrange for production of the special
10 license plates. Following approval by the Wyoming
11 department of transportation, special cancer prevention and
12 awareness license plates shall be subject to redesign on
13 the same schedule as all license plates beginning with the
14 year 2025 reissuance. The license plates shall be issued by
15 the county treasurer of each county.

16

17 (e) The department may prepare any special forms and
18 issue any rules and regulations necessary to carry out this
19 section.

20

21 (f) Unless one thousand (1,000) sets of license
22 plates are issued under this section before December 31,
23 2023, the plate authorized under this section shall be
24 eliminated from production and the department shall report

1 the cessation of production to the legislature not later
2 than January 15, 2024.

3

4 **Section 2.** This act is effective July 1, 2013.
