5	day. The amount shall be adjusted as of July 1 each year

8	general services administration for travel within Wyoming								
9	except as provided in paragraph (ii) of this subsection;

11	(ii) One hundred nine dollars (\$109.00) per day

5 (\$50,000.00) from the general fund to the state auditor's

6 office for purposes of supplementing the per diem provided

7 to members of any state board, commission, council,

8 authority or other state entity whose rate of per diem is

9 based upon the amount of per diem paid to legislators and

10 is paid from the general fund as required by this act.

12 (c) For members of any state board, commission,

13 council, authority or other state entity whose rate of per

14 diem is based upon the amount of per diem paid to

15 legislators and is paid from a nongeneral fund source, to

16 the extent funds are available, there is appropriated from

17 those accounts and funds to those entities amounts

18 necessary to supplement the per diem provided to those

19 members as required by this act.

21 (d) The appropriations under this section shall be

22 for the period beginning with the effective date of this

23 act and ending June 30, 2022. The appropriations under
