## A JOINT RESOLUTION

for

1 A JOINT RESOLUTION petitioning Congress to call a 2 convention to propose amendments to the Constitution of the 3 United States to require a balanced federal budget. 4 5 WHEREAS, the legislature of the State of Wyoming is petitioning the Congress of the United States to call a 6 7 convention to propose amendments to the Constitution of the United States to require a balanced federal budget. 8 9 NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE 10 11 LEGISLATURE OF THE STATE OF WYOMING: 12 13 Section 1. That pursuant to Article V of the 14 Constitution of the United States, the legislature of the

State of Wyoming petitions the Congress of the United 1 States of America, at its session, to call a convention of 2 3 the states limited to proposing an amendment to the Constitution of the United States requiring that in the 4 absence of a national emergency, including, but not limited 5 to, an attack by a foreign nation or terrorist organization 6 7 within the United States of America, the total of all federal appropriations made by the Congress for any fiscal 8 9 year may not exceed the total of all estimated federal revenues for that fiscal year, together with any related 10 11 and appropriate fiscal restraints.

13 Section 2. That this application is to be considered 14 as covering the balanced budget amendment language of the presently outstanding balanced budget applications from 15 other states, including, but not limited to, previously 16 adopted applications from Alabama, Alaska, Arkansas, 17 18 Colorado, Florida, Georgia, Indiana, Iowa, Kansas, Louisiana, Maryland, Michigan, Mississippi, Missouri, 19 Nebraska, Nevada, New Hampshire, New Mexico, North 20 21 Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, South 22 Dakota, Tennessee, Texas, Utah and West Virginia. This application shall be aggregated with those applications for 23

1 the purpose of attaining the two-thirds (2/3) of states 2 necessary to require Congress to call a convention for 3 proposing a balanced budget amendment, but shall not be 4 aggregated with any applications on any other subject.

5

6 3. That this application constitutes Section а 7 continuing application in accordance with Article V of the Constitution of the United States until the legislatures of 8 at least two-thirds (2/3) of the several states have made 9 10 applications on the same subject. This application 11 supersedes all previous applications by this legislature on 12 the same subject.

Section 4. That the Secretary of State of Wyoming transmit copies of this resolution to the President of the United States, to the President of the Senate and the Speaker of the House of Representatives of the United States Congress, to the Wyoming Congressional Delegation and to the presiding officers of each of the legislative houses in the several states, requesting their cooperation.
