- 1 A JOINT RESOLUTION requesting Congress to oppose House
- 2 Resolution 980, titled the Northern Rockies Ecosystem
- 3 Protection Act.

- 5 WHEREAS, H.R. 980 was introduced in the United States House
- 6 of Representatives on February 11, 2009; and

7

- 8 WHEREAS, H.R. 980 would designate an additional six million
- 9 five hundred fourteen thousand (6,514,000) acres to the
- 10 national wilderness system in the Greater Yellowstone
- 11 Ecosystem, regardless of their unsuitability and failure to
- 12 meet the wilderness criteria outlined in the 1964
- 13 Wilderness Act; and

- 2 WHEREAS, these additions to the National Wilderness System
- 3 will have tremendous negative impacts to the economies of
- 4 the counties in which they occur and ultimately to the
- 5 economy of surrounding counties and the State of Wyoming;
- 6 and

- 8 WHEREAS, the continuance of all multiple use activities,
- 9 including motorized recreation, outfitting, grazing, timber
- 10 harvesting activities and mineral development is crucial to
- 11 the long term economic diversity of all Wyoming counties
- 12 and the State of Wyoming; and

- 14 WHEREAS, the Wyoming congressional delegation, representing
- 15 a state heavily impacted by the proposed wilderness
- 16 expansion, is not on record in support of the designation;
- 17 and

- 19 WHEREAS, the United States Congress does not customarily
- 20 make wilderness designations without first seeking
- 21 concurrence with the states affected.

- 23 NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE
- 24 LEGISLATURE OF THE STATE OF WYOMING:

2 Section 1. That the Legislature of the State of 3 Wyoming is adamantly opposed to the Northern Rockies 4 Ecosystem Protection Act, H.R. 980, and hereby requests 5 that the United States House of Representatives Natural

Resources Committee oppose this legislation.

Section 2. That the Secretary of State of Wyoming 8 9 transmit copies of this resolution to the President of the 10 United States, to the President of the Senate and the Speaker of the House of Representatives of the United 11 12 States Congress and to the Wyoming Congressional 13 Delegation.
