Penalties. 17 (a) Except as provided in subsection (d) of this 18 19 section, any person who violates this act is guilty of a 20 misdemeanor punishable upon conviction by a fine of not more than one thousand dollars (\$1,000.00). 21 22 23 (d) A violation of W.S. 9-13-103 or 9-13-105(a) is:

1 2 (i) A felony punishable by imprisonment for not 3 more than ten (10) years, a fine of not more than ten 4 thousand dollars (\$10,000.00), or both, if the total value 5 of the private benefit or personal or private interest is 6 one thousand dollars (\$1,000.00) or more; or 7 (ii) A misdemeanor punishable by imprisonment 8 9 for not more than six (6) months, a fine of not more than 10 seven hundred fifty dollars (\$750.00), or both, if the 11 total value of the private benefit or personal or private 12 interest is less than one thousand dollars (\$1,000.00). 13 14 **Section 3.** W.S. 9-13-102(a)(xii)(A) through (E) is 15 repealed. 16 17 Section 4. This act is effective July 1, 2020. 18 19 (END)
