A BILL

for

- 1 AN ACT relating to county notice publications; amending
- 2 requirements and contents for county notices and
- 3 publications; providing for online publications; and
- 4 providing for an effective date.

6 Be It Enacted by the Legislature of the State of Wyoming:

- 8 **Section 1.** W.S. 18-3-515, 18-3-516(a), (b) (intro),
- 9 (i) and by creating a new subsection (f), 18-4-306,
- 10 18-4-405, 18-6-101(b) and 18-6-201(a) are amended to read:

- 12 18-3-515. Preparation and publication of annual
- 13 statements.

14

- 15 Each board of county commissioners at their regular July
- 16 meeting shall request a statement of the receipts and

1 expenditures of the county during the preceding twelve (12)

2 months setting forth the source and amount of all receipts

3 and the purpose and the amount of all expenditures to be

4 prepared upon reconciliation of all accounts by the county

5 treasurer and county clerk, not later than September 30.

6 The statement shall be signed by the chairman and clerk of

7 the board and shall be posted on the county's designated

8 official website in the manner provided in W.S. 18-3-516(f)

9 and published at least two (2) times once in a the county's

10 designated official newspaper. of general circulation in

11 the county, or if there is none, by posting the statement

12 in three (3) public places in the county.

14 18-3-516. Publication of proceedings; publication of 15 names, salaries and wages of certain officials and

16 employees.

17

Each board of county commissioners shall post a 18 19 comprehensive summary of the entire proceedings of all regular and special meetings held by the board on the 20 21 county's official website in the manner provided in 22 subsection (f) of this section and publish the comprehensive summary of the entire proceedings of 23 24 regular and special meetings held by them one (1) time in $\frac{a}{b}$

newspaper published in the county, if any the county's 1 2 designated official newspaper. The county clerk of each 3 county shall within twelve (12) working days 4 adjournment of every meeting for which the next scheduled 5 meeting will be called to order in two (2) weeks time or less, or within eighteen (18) working 6 davs after adjournment of every meeting for which the next scheduled 7 meeting will be called to order in more than two (2) weeks 8 9 time, furnish the paper with a copy of the proceedings. Except for salaries and wages published under subsection 10 11 (b) of this section, the copy shall include any bill presented to the board stating the amount of the bill, the 12 13 amount allowed, the purpose of the bill and the claimant. 14 for part-time employees may be summarized by department without listing each part-time employee. 15 newspaper shall publish the copy of proceedings within nine 16 17 days after receipt. The board shall post on its official website, and if practicable publish, notice of the 18 19 time of all regular and special meetings.

21 (b) Each board of county commissioners shall post on 22 the county's official website in the manner provided in subsection (f) of this section and publish separate from 23

the minutes of the proceedings: 24

2	(i) During January and July of each <u>Within sixty</u>
3	(60) days after the end of each fiscal year, the name,
4	position and gross monthly salary of each chief
5	administrative official, assistant administrative official
6	and department head including those officials and
7	department heads of boards and departments funded by the
8	board of county commissioners and elected officials. The
9	publication shall also include a list of all other full-
10	time positions employed by the county without the name of
11	the current employee, including the gross monthly salary
12	for each position full-time employee and each elected
13	official. A brief statement shall accompany the salary
14	publication specifying that all salaries are listed as
15	gross monthly salaries or actual monthly wages, not
16	including any fringe benefits such as health insurance
17	costs, life insurance benefits and pension plans. The
18	statement shall also indicate that the salaries or wages do
19	not include any overtime that the employee may earn which
20	would be paid by the county; and

(f) For all publications required by statute to be posted on a county's official website, the publication shall be posted at times required for publication in a

- 1 <u>designated official newspaper</u>. Until June 30, 2016, each
- 2 board of county commissioners shall cause to be published
- 3 in the designated official newspaper once per month, no
- 4 less than twelve (12) times per year, a general public
- 5 notice pertaining to access to county information. After
- 6 June 30, 2016, this general public notice shall be
- 7 published at least once per year.

9 18-4-306. Notice of intention to issue and sell.

10

- 11 The board shall give notice by posting on the county's
- official website in the manner provided in W.S. 18-3-516(f)
- 13 and by publication in some newspaper published in the
- 14 county if there be one, otherwise by three (3) notices
- 15 posted in the county, one of which shall be at the
- 16 courthouse door of its intention to issue and negotiate the
- 17 bonds and to invite bidders therefor. The notice shall also
- 18 be published in some newspaper of general circulation in
- 19 Cheyenne the county's designated official newspaper.

20

21 18-4-405. Notice of intention to issue and sell.

22

- 23 The board of county commissioners shall give notice by
- 24 posting on the county's official website in the manner

provided in W.S. 18-3-516(f) and by publication in some newspaper published and of general circulation in the county if there be one; otherwise by three (3) notices posted in the county one (1) of which is posted at the courthouse door, of its intention to issue and negotiate the bonds and to invite bidders therefor. The notice shall also be published in some newspaper published and of general circulation in the cities of Cheyenne, Wyoming; Denver, Colorado; Chicago, Illinois and New York City, New York the county's designated official newspaper.

12 18-6-101. Authority to acquire and dispose of sites 13 generally.

(b) If a courthouse or jail to be replaced is sold it shall be sold at public auction to the highest bidder for cash or on such terms of payment as determined by the board and in case of deferred payments, security is required satisfactory to the board. No sale shall occur until public notice has been given by posting on the county's official website in the manner provided in W.S. 18-3-516(f) and by publishing in some newspaper published and of general circulation in the county the county's designated official newspaper once a week for four (4)—two (2) weeks. The

- 1 notice shall specify the time, place and terms of sale.
- 2 All proceeds of the sale shall be paid into the county
- 3 treasury and only expended for a site or toward the
- 4 erection of a new building to replace the one sold.

5

- 6 18-6-201. Construction of jails; authority of county
- 7 commissioners; plans and specifications; maximum cost
- 8 permitted; call for bids; limitations applicable only when
- 9 costs paid from general fund.

10

- 11 (a) Whenever the board of county commissioners deems
- 12 it in the best interest of the county to have a jail
- 13 constructed they shall cause plans and specifications for a
- 14 jail to be prepared by a competent architect. After the
- 15 plans and specifications are prepared, reviewed and
- 16 critiqued by the sheriff and adopted by the board of county
- 17 commissioners they shall deposit them in the office of the
- 18 county clerk for the county where they shall be available
- 19 for the inspection of all persons. The board of county
- 20 commissioners shall give notice that they will receive
- 21 sealed proposals for the building of the jail according to
- 22 the plans and specifications by posting on the county's
- 23 official website in the manner provided in W.S. 18-3-516(f)
- 24 and by publication in a the county's designated official
