6 Be It Enacted by the Legislature of the State of Wyoming:

- 8 **Section 1.** W.S. 1-20-101, 1-20-104, 1-20-105 and
- 9 1-20-106(a)(iii), (iv) and (b) are amended to read:

11 1-20-101. Homestead exemption; right and amount.

12

- 13 Every resident of the state is entitled to a homestead not
- 14 exceeding ten thousand dollars (\$10,000.00) twenty thousand
- 15 dollars (\$20,000.00) in value, exempt from execution and
- 16 attachment arising from any debt, contract or civil
- 17 obligation entered into or incurred.

2 1-20-104. Homestead exemption; composition.

3

- 4 The homestead may consist of a house and lot or lots in any
- 5 town or city, or a farm consisting or other lands of any
- 6 number of acres, or a house trailer or other movable home
- 7 and a lot or lots, whether or not the house trailer or
- 8 other movable home is equipped with wheels or resting upon
- 9 immovable support., the value of which does not exceed six
- 10 thousand dollars (\$6,000.00).

11

12 1-20-105. Wearing apparel.

13

- 14 The necessary wearing apparel of every person not exceeding
- 15 one thousand dollars (\$1,000.00) two thousand dollars
- 16 (\$2,000.00) in value, determined in the manner provided in
- 17 W.S. 1-20-106 is exempt from levy or sale upon execution,
- 18 writ of attachment or any process issuing out of any court
- 19 in this state. Necessary wearing apparel shall not include
- 20 jewelry of any type other than wedding rings.

- 22 1-20-106. Exemption of other personal property;
- 23 personalty used in livelihood; appraisement.

1 (a) The following property, when owned by any person, 2 is exempt from levy or sale upon execution, writ of 3 attachment or any process issuing out of any court in this 4 state and shall continue to be exempt while the person or 5 the family of the person is moving from one (1) place of residence to another in this state: 6 7 (iii) Furniture, bedding, provisions and other 8 9 household articles of any kind or character as the debtor may select, not exceeding in all the value of two thousand 10 dollars (\$2,000.00) four thousand dollars (\$4,000.00). When 11 two (2) or more persons occupy the same residence, each 12 13 shall be entitled to a separate exemption; 14 (iv) The value in a motor vehicle not exceeding 15 in value two thousand four hundred dollars (\$2,400.00) five 16 17 thousand dollars (\$5,000.00). 18 19 The tools, team, implements or stock in trade of any person, used and kept for the purpose of carrying on 20 21 his trade or business, not exceeding in value two thousand dollars (\$2,000.00) four thousand dollars (\$4,000.00), or 22 the library, instruments and implements of any professional 23 24 person, not exceeding in value two thousand dollars

1 (\$2,000.00) four thousand dollars (\$4,000.00), are exempt
2 from levy or sale upon execution, writ of attachment or any
3 process out of any court in this state.

5 Section 2. This act is effective July 1, 2012.
