7 Be It Enacted by the Legislature of the State of Wyoming:

- 9 **Section 1.** W.S. 13-1-502 by creating a new subsection
- 10 (p) and 36-4-104(a) by creating a new paragraph (vi) are

13 13-1-502. Remote electronic terminals.

- 15 (p) A Wyoming financial institution, financial
- 16 institution or person operating a remote electronic

1 terminal in this state may enter into an agreement with the department of state parks and cultural resources to provide 2 users a voluntary opportunity to donate funds for the 3 operation and maintenance of state parks, historic sites 4 5 and recreation areas. The opportunity for donation shall be disclosed visually by electronic display in a manner 6 7 that suggests an amount of donation, allows a user to designate the amount of the donation desired, or make no 8 9 donation if so desired by the user. No additional charges 10 for making the donation shall be charged to the user by the Wyoming financial institution, financial institution or 11 person operating the remote electronic terminal. 12 13 department of state parks and cultural resources and the 14 Wyoming financial institution, financial institution or person operating the remote electronic terminal may include 15 in the agreement provisions for retention of a portion of 16 17 the donated funds as an administrative fee in an amount not to exceed ten percent (10%) of the donations collected. 18

22 (a) The department of state parks and cultural 23 resources, in consultation with the commission, may, 24 subject to the provisions of this act:

2 (vi) Enter into agreements with Wyoming 3 financial institutions, financial institutions or persons 4 operating remote electronic terminals for the collection of donations for the operation and maintenance of Wyoming 5 state parks, historic sites and recreation areas. 6 Donations received by the department pursuant to this 7 paragraph shall be deposited in an operations and 8 9 maintenance account and shall be expended by the department for the daily operation of outdoor locations and facilities 10 11 as described in W.S. 36-4-103 as appropriated by the 12 legislature. 13 14 Section 2. This act is effective immediately upon completion of all acts necessary for a bill to become law 15 as provided by Article 4, Section 8 of the 16 Constitution. 17
