State parks-acquisition of lands.

Sponsored by: Joint Travel, Recreation, Wildlife and
Cultural Resources Interim Committee

A BILL

for

1 AN ACT relating to state parks and cultural resources;
2 authorizing the acceptance of lands as specified; and
3 providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.**

8

9 (a) Subject to the provisions of subsection (b) of
10 this section, the legislature authorizes the acceptance of
11 the following lands to be managed by the department of
12 state parks and historic sites upon final negotiation with
13 the appropriate parties:

14

15 (i) Portions of Township 26N Range 66W as
16 follows:

(A) SE $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$, and SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 4;

(B) NW $\frac{1}{4}$ SW $\frac{1}{4}$, S $\frac{1}{2}$ NW $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$, and Lots 1 and
2 of Section 3;

(C) All of Lots 2 and 3 south and west of
the oxbow of the North Platte River, N $\frac{1}{2}$ SW $\frac{1}{4}$, Parcel 2 B288
P644, SW $\frac{1}{4}$ SE $\frac{1}{4}$, Lot 4 (SE $\frac{1}{4}$ SE $\frac{1}{4}$), Parcel 1 B288 P644 of
Section 2;

(D) Lots 3 and 2 and lands south of the
North Platte River in SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 1;

(E) Lands north of the County Road in the
NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 11; and

(F) N $\frac{1}{2}$ NW $\frac{1}{4}$ and Lot 2 of Section 12.

(b) Portions of land owned by Wyoming military
department included in the description in subsection (a) of
this section shall be transferred to the department in, or
managed by agreement by, phases. A property survey and
certified legal description shall be completed prior to any

1 transfer or agreement. The first phase shall include lands
2 where there are no existing conditions precluding transfer.
3 Phase II lands shall include those areas which fall within
4 current surface danger zones (SE¼ SW¼ and S½ SE¼ of Section
5 4, N½ NW¼ SW¼ of Section 2). Phase II lands shall be
6 transferred when surface danger zones have been fully
7 mitigated. The third phase shall include lands owned by
8 Wyoming military department (S½ N½ SW¼ of Section 2, Parcel
9 2 B288 P644, and lands west of the County Road in W½ SW¼
10 SE¼ of Section 2) which shall be managed by memorandum of
11 understanding describing appropriate access and
12 development. Portions of land owned by the Town of
13 Guernsey and State of Wyoming office of state lands and
14 investments included in the description in subsection (a)
15 of this section shall be managed under a memorandum of
16 understanding between the department and the owners.

18 **Section 2.** This act is effective immediately upon
19 completion of all acts necessary for a bill to become law
20 as provided by Article 4, Section 8 of the Wyoming
21 Constitution.
