

## HOUSE BILL NO. SF0060

VIN inspection authority-game and fish.

Sponsored by: Joint Transportation, Highways and Military  
Affairs Interim Committee

A BILL

for

1 AN ACT relating to the titling of vehicles; granting  
2 authority to the game and fish to perform vehicle  
3 identification number inspections as specified; authorizing  
4 a fee for VIN inspections performed by game and fish law  
5 enforcement personnel; directing the deposit of the fee;  
6 and providing for an effective date.

8 *Be It Enacted by the Legislature of the State of Wyoming:*

10 **Section 1.** W.S. 7-2-101(a)(iv)(C)(II), (III) and by  
11 creating a new subparagraph (IV) and 31-3-102(b)(intro),  
12 (iii), (iv) and by creating a new paragraph (v) are amended  
13 to read:

15 **7-2-101. Definitions.**

1 (a) As used in W.S. 7-2-101 through 7-2-107:

3 (iv) "Peace officer" means:

5 (C) Game and fish law enforcement personnel  
6 qualified pursuant to W.S. 9-1-701 through 9-1-707 and:

8 (II) While responding to requests to  
9 assist other peace officers performing their official  
10 duties or when enforcing a valid arrest warrant for any  
11 crime;~~or~~

13 (III) When enforcing any provision of  
14 title 23 and chapter 13 of title 41, any rule and  
15 regulation promulgated by the Wyoming game and fish  
16 commission or any other statute for which they are granted  
17 statutory enforcement authority;~~or~~ or

19 (IV) While performing a vehicle  
20 identification number (VIN) inspection on any watercraft  
21 trailer if performed contemporaneously with a hull  
22 identification number (HIN) inspection or motorboat  
23 certificate of number inspection on a watercraft being  
24 carried on the trailer.

2           **31-3-102. Miscellaneous fees.**

3

4           (b) A ten dollar (\$10.00) fee shall be collected for  
5 each vehicle identification number or rebuilt salvage  
6 vehicle decal inspected pursuant to W.S. 31-2-103(a)(vi) or  
7 31-2-108(d). If a vehicle is presented for inspection of  
8 both vehicle identification number and rebuilt salvage  
9 vehicle decal at the same time, or both vehicle  
10 identification number (VIN) and hull identification number  
11 (HIN) or motorboat certificate of number inspection at the  
12 same time, only one (1) fee of ten dollars (\$10.00) shall  
13 be collected. The fee shall be deposited as follows:

15           (iii) If the inspection is performed by a state  
16 trooper then in the state's general fund; ~~or~~

18           (iv) If the inspection is performed by a law  
19 enforcement officer in a state other than Wyoming then in  
20 the general fund of the county where application for  
21 certificate of title is made; ~~or~~ or

23           (v) If the inspection is performed by game and  
24 fish law enforcement personnel pursuant to W.S.

1 7-2-101(a)(iv)(C)(IV) then in the state's game and fish  
2 fund.

4 **Section 2.** This act is effective July 1, 2014.
