1 AN ACT relating to local government funding; reducing a  
2 prior appropriation; making conforming changes to the  
3 related funding formulas; and providing for an effective  
4 date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8       **Section 1.** 2020 Wyoming Session Laws, Chapter 33,  
9 Section 1(a)(intro), (b)(intro) and (c)(intro) is amended

14       **Section 1.**

1           (a) From the legislative stabilization  
2 reserve account created by W.S. 9-4-219(a) there  
3 is appropriated ~~one hundred five million dollars~~  
4 ~~(\$105,000,000.00)~~ ninety-four million five  
5 hundred thousand dollars (\$94,500,000.00) to the  
6 office of state lands and investments ~~to~~ as  
7 provided in this subsection. Fifty-two million  
8 five hundred thousand dollars (\$52,500,000.00)  
9 shall be available in the first fiscal year of  
10 the biennium and forty-two million dollars  
11 (\$42,000,000.00) shall available in the second  
12 fiscal year of the biennium. The appropriation  
13 shall be allocated pursuant to the following and  
14 as further provided in this section:

18           (b) Funds appropriated in paragraphs (a)(i)  
19 and (iii) of this section shall be distributed to  
20 cities and towns ~~with one half (1/2) of~~ based on  
21 the amount ~~available distributed in the first~~  
22 appropriated for each fiscal year of the biennium  
23 ~~and one half (1/2) of the amount available~~

1 ~~distributed in the second fiscal year of the~~  
2 ~~biennium~~ under subsection (a) of this section.

3 Distributions in each fiscal year shall be made  
4 in equal amounts on August 15 and January 15 of  
5 each fiscal year as calculated prior to the  
6 August 15 distribution, subject to the following:

10 (c) Funds appropriated in paragraphs  
11 (a)(ii) and (iv) of this section are to be  
12 distributed to counties ~~with one half (1/2) of~~  
13 based on the amount ~~available distributed in the~~  
14 first appropriated for each fiscal year of the  
15 biennium ~~and one half (1/2) of the amount~~  
16 ~~available distributed in the second fiscal year~~  
17 ~~of the biennium~~ under subsection (a) of this  
18 section. Distributions in each fiscal year shall  
19 be made in equal amounts on August 15 and January  
20 15 of each fiscal year as calculated prior to the  
21 August 15 distribution. From these distributions  
22 each county shall receive the following:

1           **Section 2.** This act is effective immediately upon  
2 completion of all acts necessary for a bill to become law  
3 as provided by Article 4, Section 8 of the Wyoming  
4 Constitution.
