8 Be It Enacted by the Legislature of the State of Wyoming:

10 **Section 1.** W.S. 36-3-112 is created to read:

- 12 36-3-112. Office of private lands and energy
- 13 **ombudsman**.

(a) There is created within the office of state lands 1 2 and investments the office of private lands and energy 3 ombudsman. The position of the ombudsman shall be employed 4 by the director as a deputy director within the office of state lands and investments in the same manner as provided 5 in W.S. 36-3-111 and shall report directly to the director. 6 7 8 (b) The office of private lands and energy ombudsman 9 shall: 10 11 (i) Provide information to assist private land 12 owners and mineral or energy companies in their efforts to 13 comply with Wyoming laws and regulations as they relate to mineral or energy access, development or transmission on 14 15 private lands. The information provided under this 16 paragraph may include, without limitation, the following: 17 18 (A) Split estates; 19 20 (B) Seismic activity; 21 22 (C) Use of eminent domain; 23

1 (iii) Develop written and electronic materials 2 describing the legal responsibilities of land owners and 3 mineral or energy companies under the laws of this state; 4 5 (iv) Maintain records of each request assistance received by the office of private lands and 6 energy ombudsman under this section including the nature of 7 8 the request, the assistance provided and the outcome of the 9 issue if applicable; 10 11 Direct parties to dispute resolution  $(\nabla)$ 12 processes including mediation, arbitration or the informal procedures for resolving disputes established pursuant to 13 14 W.S. 11-41-101 et seq. upon request to the Wyoming 15 agriculture and natural resource mediation board when 16 necessary; 17 18 (vi) Investigate areas in dispute or where one 19 (1) party is alleged to have not complied with state law 20 and provide written findings of fact to both parties; 21 22 (vii) If federal rules and regulations apply, 23 provide the landowners and mineral or energy companies with

2 jurisdiction.

4 (c) The board of land commissioners may adopt rules
