9 Be It Enacted by the Legislature of the State of Wyoming:

11 Section 1.

12

- 13 (a) There is created a select committee to study
- 14 issues relating to building defects at the Wyoming state

1 penitentiary at Rawlins, Wyoming and associated inmate

2 housing issues. The committee shall consist of:

3

4 (i) Five (5) members of the Wyoming senate to be

5 appointed by the president of the senate. At least one (1)

6 member shall be from the minority party;

7

8 (ii) Five (5) members of the Wyoming house of

9 representatives to be appointed by the speaker of the

10 house. At least one (1) member shall be from the minority

11 party.

12

13 (b) The cochairmen of the select committee shall be

14 appointed by the president of the senate and the speaker of

15 the house, respectively.

16

17 (c) The legislative service office shall staff the

18 select committee. State agencies shall provide information

19 and assistance to the select committee as requested.

20

21 (d) The committee shall study and make

22 recommendations for solutions related to building

23 deficiencies at the Wyoming state penitentiary in Rawlins

1 and associated inmate housing issues. The committee shall

2 review the feasibility of repairing or adding to the

3 current penitentiary, construction of a new penitentiary in

4 Rawlins, and relocation of all or a portion of the

5 penitentiary population to an existing or new facility in

6 another location in the state. The committee shall

7 consider existing and future projected inmate populations,

8 capacity of communities and the department of corrections

9 to adequately staff a facility, cost of repair and new

10 construction, expected life cycles, timeframes and other

11 items as the committee determines prudent to adequately

12 address the issues under study.

13

14 (e) The committee shall report its findings to the

15 joint appropriations committee and the joint judiciary

16 interim committee not later than October 1, 2016. The joint

17 appropriations committee and joint judiciary interim

18 committee may introduce legislation in the 2017 general

19 session as each determines appropriate to address issues

20 studied pursuant to this act.

21

22 (f) The select committee shall terminate December 31,

23 2016.

2 **Section 2.** There is appropriated from the general

3 fund to the legislative service office seventy thousand

4 dollars (\$70,000.00) for purposes of this act.

6 **Section 3.** This act is effective immediately upon

7 completion of all acts necessary for a bill to become law

8 as provided by Article 4, Section 8 of the Wyoming

9 Constitution.
