9 Section 1.

- 11 (a) There is created a select committee on United
- 12 States Constitution Article V conventions consisting of the
- 13 following members:

(i) Five (5) members of the Wyoming senate 1 2 appointed by the president of the senate, one (1) of whom 3 shall be designated as cochairman; 4 5 (ii) Five (5) members of the Wyoming house of representatives, appointed by the speaker of the house, one 6 (1) of whom shall be designated as cochairman. 7 8 9 (b) The select committee shall be staffed by the legislative service office. 10 11 The select committee shall, as related to Article 12 V of the United States Constitution: 13 14 15 (i) Collect information regarding all requests for an Article V convention from the other states, 16 17 including the specific subject matter of all proposed amendments; 18 19 20 (ii) Determine the applicability to Wyoming of 21 the proposed amendments identified pursuant to paragraph

(i) of this subsection;

1 (iii) Prepare and submit to the legislature for

2 concurrence a list of recommended amendments to the United

3 States constitution to be included in a request for an

4 Article V convention.

6 (d) The select committee shall have authority to

7 establish procedures for corresponding with and exchanging

8 information with the other states.

10 (e) Upon approval of the legislative management

11 council, the select committee shall establish and

12 communicate to the other states an appropriate mechanism

13 for engaging the Wyoming legislature's involvement in any

14 Article V summits, meetings or conventions among one (1) or

15 more other states.

17 (f) The select committee shall conduct at least two

18 (2) public meetings in Wyoming before recommending any

19 constitutional amendments to the legislature. In addition,

20 each select committee member may be reimbursed travel

21 expenses to attend up to one (1) out-of-state meeting

22 related to Article V for the purpose of gaining information

23 from other states on any proposed Article V amendments and

1 developing a network among states proposing the same

2 constitutional amendment or amendments.

4 (g) The select committee shall submit a final report

5 to all members of the legislature regarding the select

6 committee's results and recommendations on or before

7 October 1, 2014. The report shall include the status of

8 any other state requests for an Article V convention and

9 the level of support from other states, by subject matter,

10 for each such request.

11

12 Section 2. There is appropriated from the general

13 fund forty thousand dollars (\$40,000.00) to the legislative

14 service office for payment of salary, per diem and mileage

15 for legislative select committee members for the purposes

16 of this act.

17

18 Section 3. This act is effective immediately upon

19 completion of all acts necessary for a bill to become law

20 as provided by Article 4, Section 8 of the Wyoming

21 Constitution.
