- 7 **Section 1.** W.S. 15-1-601 by creating new subsections
- 8 (e) and (f) and 18-5-201 are amended to read:

- 10 15-1-601. Regulations; scope and purpose; uniformity
- 11 within authorized districts; to follow plan; objectives.

- 13 (e) No regulation, ordinance, resolution, condition
- 14 of development, comprehensive plan or subdivision plan
- 15 shall include or require:

2	(i) The direct or indirect allocation or
3	dedication of a percentage of existing or newly constructed
4	residential or commercial units for affordable or workforce
5	housing; or
6	
7	(ii) Any monetary exaction for the acquisition
8	of land, construction, dedication or rehabilitation of
9	affordable or workforce housing units.

11	(f) Nothing in subsection (e) of this section shall
12	limit the authority of the governing body of any city or
13	town to implement an incentive based program designed to
14	increase the construction, dedication or rehabilitation of
15	affordable and workforce housing.

17	18-5-201. Authority vested in board of county
18	commissioners; inapplicability of chapter to incorporated
19	cities and towns and mineral resources.

21	(a) To promote the public health, safety, morals and
22	general welfare of the county, each board of county
23	commissioners may regulate and restrict the location and

1	use of buildings and structures and the use, condition of
2	use or occupancy of lands for residence, recreation,
3	agriculture, industry, commerce, public use and other
4	purposes in the unincorporated area of the county. However,
5	nothing in W.S. 18-5-201 through 18-5-208 shall be
6	construed to contravene any zoning authority of any
7	incorporated city or town and no zoning resolution or plan
8	shall prevent any use or occupancy reasonably necessary to
9	the extraction or production of the mineral resources in or
10	under any lands subject thereto. No regulation, ordinance,
11	resolution, condition of development, comprehensive or
12	subdivision plan shall include or require:

14	(i) The direct or indirect allocation or
15	dedication of a percentage of existing or newly constructed
16	residential or commercial units for affordable or workforce

1 (b) Nothing in this section shall effect the 2 authority of the board of county commissioners to implement 3 an incentive based program designed to increase the 4 construction, dedication or rehabilitation of affordable 5 and workforce housing. 6 Section 2. This act shall apply to all existing and 7 future regulations, ordinances, resolutions and conditions 8 9 of development. 10 11 Section 3. This act is effective immediately upon 12 completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming 13 Constitution. 14 15 16 (END)
