A BILL

for

- 1 AN ACT relating to the military; providing appropriations
- 2 for national guard armories; specifying the use of funds;
- 3 and providing for an effective date.

5 Be It Enacted by the Legislature of the State of Wyoming:

6

- 7 **Section 1.** The military department shall modify and
- 8 improve the facilities in a portion of its national quard
- 9 armories to better meet the armories' intended purpose and
- 10 serve the Wyoming communities in which the armories are
- 11 located.

- 13 Section 2. For the armory at or near Rock Springs,
- 14 Wyoming, there is appropriated from the general fund to the
- 15 military department three hundred sixty-five thousand five

- 1 hundred fifty-nine dollars (\$365,559.00) to modify the
- 2 latrine area and to improve the kitchen area.

3

- 4 Section 3. For the armory at or near Lander, Wyoming,
- 5 there is appropriated from the general fund to the military
- 6 department nine hundred sixteen thousand six hundred
- 7 twenty-three dollars (\$916,623.00) to modify the latrine
- 8 area and to improve the kitchen area.

9

- 10 **Section 4.** For the armory at or near Evanston,
- 11 Wyoming, there is appropriated from the general fund to the
- 12 military department three hundred thousand eight hundred
- 13 seventy-four dollars (\$300,874.00) to modify the latrine
- 14 area and to improve the kitchen area.

15

- 16 **Section 5.** For the armory at or near Douglas,
- 17 Wyoming, there is appropriated from the general fund to the
- 18 military department seven hundred ninety-nine thousand
- 19 forty dollars (\$799,040.00) to modify the latrine area and
- 20 to improve the kitchen area.

21

- 22 **Section 6.** For the armory known as Cheyenne 115th, at
- 23 or near Cheyenne, Wyoming, there is appropriated from the
- 24 general fund to the military department one million three

1 hundred seventy-one thousand one hundred sixty-three

2 dollars (\$1,371,163.00) to modify the latrine area.

3

4 Section 7. For the armory at or near Torrington,

5 Wyoming, there is appropriated from the general fund to the

6 military department three hundred fifteen thousand dollars

7 (\$315,000.00) to improve the kitchen area.

8

9 **Section 8**. For the armory at or near Sheridan,

10 Wyoming, there is appropriated from the general fund to the

11 military department six hundred eighty-nine thousand five

12 hundred twenty-four dollars (\$689,524.00) to modify the

13 latrine area and to improve the kitchen area.

15 **Section 9.** Notwithstanding any other provision of

law, the appropriations made in sections 2 through 8 of

17 this act shall not be transferred or expended for any other

18 purpose other than for the purpose specified in each

19 section. Unexpended and unobligated funds shall revert on

20 June 30, 2014.
