sell, transfer or use any abortifacient drug in the state 1 2 for the purpose of procuring or performing an abortion. 3 4 (b) The prohibition in subsection (a) shall not apply 5 to: б 7 (i) A woman upon whom an abortion is performed or attempted in which an abortifacient drug is used; 8 9 10 (ii) The sale, use, prescription or 11 administration of any other contraceptive agent 12 administered before conception or before pregnancy can be confirmed through conventional medical testing; 13 14 15 (iii) Treatment of а natural miscarriage 16 according to currently accepted guidelines; 17 18 (iv) Treatment necessary to preserve the woman 19 from an imminent peril that substantially endangers her 20 life or health, according to appropriate medical judgment. 21 22 (c) Any physician or other person who violates subsection (a) of this section is guilty of a misdemeanor 23
