| 14 | (a) A brand inspector may inspect livestock being           |

| 17 | (d) Any inspector, game warden or peace officer of          |
| 18 | the county or state of Wyoming shall obtain a search        |
| 19 | warrant prior to seizing and taking into custody any        |
| 20 | livestock which are unlawfully in possession when the       |
| 21 | livestock are located in open pastures on private or leased |
| 22 | lands. If the person in charge of the property where the    |
| 23 | livestock are located consents in writing to a search of    |
| 24 | the conveyance or property without a warrant, the search    |
