Continuation of special districts task force.

A BILL

for

1 AN ACT relating to the administration of government;
2 continuing the task force on special districts as
3 specified; requiring a report; extending an appropriation;
4 providing an appropriation; and providing for an effective
5 date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

9 **Section 1.** 2016 Wyoming Session Laws, Chapter 80,
10 Section 1(e), (f), (h) and by creating a new subsection (j)
11 is amended to read:

13 **Section 1.**

1 (e) The task force shall submit ~~a report~~
2 annual reports summarizing its studies, findings
3 and recommendations to the joint corporations,
4 elections and political subdivisions interim
5 committee. The task force shall submit its first
6 report on or before September 15, 2016 and its
7 second report on or before September 15, 2017.

8 The joint corporations, elections and political
9 subdivisions interim committee shall consider the
10 recommendations and develop any legislation it
11 deems appropriate for consideration by the
12 legislature. If the recommendations made by the
13 task force suggest a multi-year approach to
14 addressing special district issues, the joint
15 corporations, elections and political
16 subdivisions interim committee may consider
17 sponsoring legislation for the continuation of
18 the task force.

19
20 (f) The task force shall exist until
21 December 31, ~~2016~~2017. Members of the task
22 force who are not state employees or legislators
23 shall not receive a salary but shall receive

1 reimbursement for mileage and per diem expenses
2 at a rate provided for legislators under W.S.
3 28-5-101. Members of the task force who are
4 legislators shall be paid salary, per diem and
5 mileage, but no salary for preparation, as
6 provided in W.S. 28-5-101 for their official
7 duties as members of the task force.

8
9 (h) Funds appropriated under subsection (g)
10 of this section shall be for the period beginning
11 with the effective date of this act and ending
12 June 30, ~~2017~~2018 and shall be expended only for
13 the purpose of providing the payments to task
14 force members authorized in subsection (g) of
15 this section.

16
17 (j) In addition to the amounts appropriated
18 in subsection (g) of this section, there is
19 appropriated from the general fund twenty-one
20 thousand dollars (\$21,000.00) to the legislative
21 service office for the payment of expenses for
22 the task force. Funds appropriated under this
23 section shall not be transferred or expended for

1 any other purpose and any unexpended, unobligated
2 funds remaining from this appropriation shall
3 revert as provided by law on June 30, 2018.

4

5 **Section 2.** This act is effective immediately upon
6 completion of all acts necessary for a bill to become law
7 as provided by Article 4, Section 8 of the Wyoming
8 Constitution.
