A BILL

for

1 AN ACT relating to the legislature; amending provisions
2 relating to the selection of a management council member at
3 large; and providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 28-8-102(a) is amended to read:

9 **28-8-102. Management council; membership; vacancies;**
10 **meetings; rules and regulations; quorum; officers.**

12 (a) Activities of the office shall be directed by a
13 management council composed of the president, vice president,

1 majority and minority floor leaders or their respective
2 designees of the senate, plus two (2) senators selected at
3 ~~large; not more than one (1) of which shall be from the same~~
4 ~~political party as the president;~~ and the speaker, speaker
5 pro tempore, majority and minority floor leaders or their
6 respective designees of the house plus two (2)
7 representatives selected at large ~~, not more than one (1) of~~
8 ~~which shall be from the same political party as the speaker.~~
9 The two (2) senators selected at large shall be selected by
10 ~~caucus of the two (2) major political parties in the senate,~~
11 ~~meeting separately a majority vote of all members of the~~
12 ~~senate~~, and the two (2) representatives selected at large
13 shall be selected by ~~caucus of the two (2) major political~~
14 ~~parties of the house, meeting separately a majority vote of~~
15 ~~all members of the house~~. These twelve (12) members shall
16 select one (1) additional member at large ~~from the minority~~
17 party from the house of which the chairman of the management
18 council is not a member. ~~The member at large shall not be~~
19 ~~from the same party as the chairman of the management council.~~
20 Chairmanship of the management council shall be rotated
21 between the house and senate after each two (2) year session
22 so that the chairman shall not be from the same house as the
23 chairman who served for the preceding legislative term. The

1 members of the management council shall be the legislative
2 representatives in directing the day-to-day functions of the
3 office and the entire membership of the legislature shall
4 have the ultimate control and supervision over policy of the
5 office.

6

7 **Section 2.** This act is effective immediately upon
8 completion of all acts necessary for a bill to become law as
9 provided by Article 4, Section 8 of the Wyoming Constitution.
