A JOINT RESOLUTION

for

- 1 A JOINT RESOLUTION making an application to the United

- 7 WHEREAS, Article IV, Section 4 of the Constitution of the
- 8 United States guarantees to every state a republican form
- 9 of government that gives each state equal standing when
- 10 calling for an Article V amendment convention; and

- 12 WHEREAS, Article V of the Constitution of the United States
- 13 reserves to the state legislatures the right to apply for
- 14 an amendment convention for the purpose of proposing
- 15 amendments to the United States Constitution when Congress,

1 the courts or the executive branch refuse to address an

2 egregious wrong suffered by the people; and

3

4 WHEREAS, the state legislatures alone have the authority to

5 limit the agenda and authority of delegates and alternates

6 they send to an Article V convention. This authority does

7 not reside in the United States Congress, nor in the

8 federal or state courts, nor in the federal or state

9 executive branches; and

10

11 WHEREAS, Congress, under Article V of the United States

12 Constitution, is required to call for an amendment

13 convention as directed and defined by the state

14 legislatures of the several states.

15

16 NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE

17 LEGISLATURE OF THE STATE OF WYOMING:

18

19 **Section 1.** That the Wyoming State Legislature hereby

20 applies to the United States Congress, under the provisions

21 of Article V of the United States Constitution, to call a

22 single-issue countermand amendment convention for the

23 purpose of deciding whether the pre-approved proposed

1 countermand amendment should be returned to the state

2 legislatures for ratification.

4 Section 2. That the application in section 1 of this

5 resolution constitutes a continuing application in

6 accordance with Article V of the Constitution of the United

7 States until the legislatures of at least two-thirds (2/3)

8 of the several states have made identical or substantially

9 similar applications.

10

11 Section 3. That Congress is directed to convene the

12 countermand amendment convention within sixty (60) days

13 from the date it receives the same or similar application

14 from two-thirds (2/3) of the several states.

Section 4. That the Secretary of State of Wyoming 1 transmit copies of this resolution to the President of the 2 3 United States, to the President of the Senate and the Speaker of the House of Representatives of the United 4 States Congress, to the Wyoming Congressional Delegation 5 6 and to the presiding officers of the legislatures of each 7 of the other forty-nine (49) states, requesting their cooperation with the purposes of this resolution. 8
